She has a MSW degree and a Ph.D. in government from Florida State University. She has worked in a detoxification center, halfway house, and outpatient chemical dependency treatment program. She is also coauthor of *Chemical Dependency: A Systems Approach, 4th ed.* (Allyn & Bacon, Fall 2011) and *Social Work: Issues and Opportunities in a Challenging Profession, 3rd ed.* (Lyceum Books, 2008). Her research is on substance abuse, violence against women, and social welfare policy. Dr. DiNitto has served on the boards of the Council and Social Work Education, the Association of Medical Education and Research on Substance Abuse, and the Texas Research Society on Alcoholism. She currently chairs the NASW Press Book Committee.
